This process can be time consuming, so please be sure that you arrive early enough to go through this process. Depending on the number of proxies you carry, you may want to plan on arriving 30-45 minutes early. Credentials will close at 9:00am and anyone not credentialed by 9:00am will not be permitted to vote. Also, please know that I.D. will be required when checking in.

### WHERE TO SIT:

The meeting hall will be laid out by Legislative District. Once you go through credentials, find where your district is sitting and sit with them. It can be crowded - another reason to arrive early!

### WHAT TO EAT:

There will be coffee and doughnuts available in the AM and two food trucks for lunch. If you think you will need additional food or drinks, you will need to bring them with you. Note: Only water is allowed inside the building.

## STANDING RULES OF THE JANUARY 13, 2018 MARICOPA COUNTY REPUBLICAN COMMITTEE MANDATORY MEETING

The Rules Committee submits the following as the proposed Rules to govern the Mandatory Meeting of the Maricopa County Republican Committee (MCRC) on January 13, 2018.

The report of the Committee on Standing Rules is presented to the members of the meeting after the adoption of that of the Credentials Committee. The vote is taken and a 2/3 vote is required to adopt the Standing Rules of the Mandatory Meeting.

**Rule 1. Procedural Authority** - The rules contained in the current edition of Robert's Rules of Order, Newly Revised, shall govern the meeting in all cases in which they are applicable and in which they are not inconsistent with the bylaws of the organization.

**Rule 2. Voting Body** - Pursuant to MCRC Bylaws Article V, Section 2(B), and Article IV, Section 3, elected precinct committeemen (PCs) and PCs appointed by the Maricopa County Board of Supervisors not less than forty-five (45) days prior to this meeting shall be entitled to be credentialed at this meeting or have their proxy carried by a registered Republican currently residing in their same precinct.

**Rule 3. Debate** - Only credentialed voting members shall have the privilege to speak in debate or discussion. No credentialed voting member shall speak more than once to the same question and will speak for no longer than one (1) minute. There will be a maximum time of three (3) minutes allowed for each affirmative and negative side of the debate on a pending question.

**Rule 4. Nominations** - Following the report of the Nominating Committee, nominations from the floor will be in order (MCRC Bylaws, Article IV, Sec 1B). Each candidate is entitled to candidate speeches not to exceed a total of two (2) minutes.

**Rule 5. Bylaw Amendments** - Pursuant to MCRC Bylaws Article X, Section 1, only proposed amendments that were sent in the notice of the meeting may be considered. No amendments or changes to a proposed amendment will be heard from the floor or considered at any time.

**Rule 6. Resolutions** - Pursuant to MCRC Bylaws Article VIII, Section 4, all resolutions not proposed by the Resolutions Committee shall be submitted forty-five (45) days prior to the date of the meeting. Floor resolutions may be brought to the floor of the meeting only if submitted to the Resolutions Committee no later than 9:00am and only if sponsored by a minimum of one hundred (100) PCs **present**, representing at least six (6) Legislative Districts and must be submitted with sufficient copies for all voting members present in person (MCRC Bylaws, Article VII, Section 4D). No amendments or changes to a proposed resolution will be heard from the floor or considered at any time.

**Rule 7. Amending Rules** - After adoption, these rules may be amended by a two-thirds (2/3) vote of those members present, either in person or by proxy, as declared by the approved report of the Credentials Committee.

### PROPOSED RESOLUTIONS

#### **#1 – REAL PROPERTY THEFT | Submitted by Duane Engdahl, LD20**

**WHEREAS**, it is never okay to covet and steal another's property; **WHEREAS**, current Arizona State Statute enables a covetous land thief to steal real property from an entitled land owner; **NOW BE IT RESOLVED**, that Arizona State Statute be revised to repeal/reform all such real property theft enablement clauses including ARS 12-522 through 529.

#### **#2 – SEXUAL HARASSMENT AND MISCONDUCT BY ELECTED OFFICIALS ARE UNACCEPTABLE | Submitted by Dave Ryan, LD15**

**WHEREAS**, the Republican Party stands for core principles such as; Freedom, Constitutional fidelity, Individual Responsibility, and Limited Government; **WHEREAS**, the Republican Party elected officials lead with maturity, integrity, intellectual honesty and serve as role models for responsible behavior for all citizens; **WHEREAS**, current Arizona Legislature policies and methods of accountability with respect to sexual harassment and misconduct appear unable to facilitate reporting of issues and holding each other accountable; **NOW, BE IT RESOLVED**, that the Maricopa County Republicans call upon the Republican leaders of the Arizona State Legislature to establish and publish policies with respect to no tolerance for sexual harassment and misconduct.

## MCRC BYLAWS - Proposed Amendments

**#1 - DEFINITIONS - 14.** The “Statutory Organizational Meeting” of the MCRC convenes each odd numbered year to elect statutory officers by PCs who have been elected at the primary election prior to the Statutory Organizational Meeting. **15.** The “Mandatory Meeting” of the MCRC convenes each even numbered year to elect non-statutory officers and Members At Large by Elected PCs, and also PCs appointed not less than forty-five (45) days prior to the Mandatory Meeting.

*REASON: Adding 14. And 15. To clarify differences between Statutory and Mandatory Meetings.*

**#2 - ARTICLE II – MEMBERS Section 2 - PCs E. Duties of PC** The duties of PCs shall include, but not be limited to: 1. Voting, in person or by proxy, at each and every district and county party election when qualified to do so, 2. Assisting the Republican Party in voter registration, 3. Assisting and encouraging Republican voters to vote on election days, 4. Attending all District meetings, 5. Working within the precinct from which elected, 6. Creating enthusiasm and support for the Republican Party, 7. Helping elect worthy Republican candidates, 8. Recruiting and training leaders of the Republican Party, and 9. Fostering loyalty to the Republican Party and promote its ideals. ~~10. The PC shall provide the district, county, and state party offices with an email address, if they have one. District, county and state party offices may not allow email addresses to be used for any purpose other than internal party communications and shall not distribute an email address to anyone, including other PCs without the express consent of the affected precinct committeeman.~~

*REASON: Removes the demand of a PC to supply an email address.*

**#3 - ARTICLE II – MEMBERS Section 3 - Precinct Captain A. Election of Precinct Captain** The District Chairman shall direct the PCs of each precinct to meet ~~during the district’s organizational meeting~~ **ON OR AFTER OCTOBER 1 ON EVEN-NUMBERED YEARS** and elect from among their number a Precinct Captain.

*REASON: Gives flexibility to Districts to plan PC Captain elections and also conforms to the new state statute.*

**#4 - ARTICLE II – MEMBERS Section 6 Qualification for Legislative District Office** A requirement to resign as an LD Officer upon assuming or opening a campaign for an elective office will not apply for a non-partisan, non-paid position (e.g. School Boards, Water Conservation District, et al.)

*REASON: Allow individual Districts, rather than MCRC, to determine whether or not a current LD Officer may continue to serve in that role while campaigning for or assuming another elected office.*

**#5 - ARTICLE III - OFFICERS Section 3 - Duties of Elected Officers E. Maricopa County Republican Secretary** The duties of the MCRC Secretary shall be to: 1. Keep minutes of all meetings of the MCRC and the EGC, 2. Transmit all calls for the meetings, 3. Ascertain, compile and transmit the agenda for the meetings as requested by the chairman, 4. Keep a current roster of the MCRC membership and records of attendance at all EGC meetings, 5. Perform functions as may be incidental to the office or may be assigned by the EGC, and 6. Update and preserve all permanent records and relinquish all MCRC records to the successor **AT THE EXPIRATION OF THE TERM.**

*REASON: Adds specificity as to when the outgoing MCRC Secretary shall relinquish records to the successor.*
